

**RENEWAL AGREEMENT
FOR REFUSE REMOVAL SERVICE CONTRACT**

THIS RENEWAL AGREEMENT (the "Renewal Agreement") is entered into effective as of the **31** day of MAY, 2022 (the "Effective Date") by and between the **City of Norton, Ohio** an Ohio Municipal Corporation ("City") and **Republic Services of Ohio Hauling, LLC dba Republic Services** ("Operator") (collectively referred to herein as the "Parties").

WITNESSETH

WHEREAS, the City and Operator are parties to that certain Collection and Transportation Agreement dated May 9th, 2016 (the "Contract") for collection and disposal of "Municipal Solid Waste and Recycling Services" in the City, expiring on June 30, 2021, attached hereto and made a part hereof as "EXHIBIT "A", and;

WHEREAS the City desired to extend the Contract for collection and disposal of municipal solid waste and processing of recyclable materials for an additional term of one (1) year, a Renewal Agreement was executed June 30th, 2021, which expires June 30th, 2022.

WHEREAS, in accordance with said agreement, and the City Administrative Officer is hereby authorized by the City Council to enter into an extension agreement with the "Operator", to provide for the collection and disposal of municipal solid waste and processing of recyclable materials for an additional term of two (2) years, in accordance with the proposal submitted, specifications, bidding instructions through and including June 30, 2024.

NOW, THEREFORE, in consideration of the mutual promises and other good and valuable consideration, the Parties hereby agree as follows:

1. **Renewal**: The parties agree that the Contract is renewed for a new term effective as of the Effective Date, and modified as provided for in this Renewal Agreement, for an additional two (2) year term beginning July 1, 2022 and terminating June 30, 2024 (the "Renewal Term").
2. **Rates**: Beginning on July 1, 2022, the rates for services provided under the Contract shall be as follow:

Unlimited Service	\$18.64
Sr. Citizen Unlimited Service	\$17.64
Limited Service*	\$16.78
Bag Service*	\$ 3.50/bag (sold in rolls of 10)

July 1, 2023 all rates will increase 3.5%

**Bulk items will be charged out the same rates as the 2016 schedule*

Other Provisions: Except as specifically modified in this Renewal Agreement, all other provisions of the Contract (as amended and updated) shall remain in full force and effect.
