The Motion for nominating Bill Helmick as Vice Chairman carried 5 – 0.

Due to the extreme weather that had been occurring with the large amounts of snow, it was discussed who would make the ultimate decision to cancel a meeting in that event. IV. PUBLIC HEARINGS: None, no applications filed.


