Mr. McGlone is elected as Vice President of Council by a vote of 7-0. Mr. McGlone took the chair as Vice-President of Council.

Mr. Price thanked all of the members for their support. Mr. Price discussed the Committee assignments and stated that he would have these selected by tomorrow. Mr. Price stated that the seating would remain in alphabetical order as was done in the past.
