Purpose of the Norton Community Reinvestment Area Housing Council

Pursuant to Section 3735.69 of the Ohio Revised Code, a community reinvestment area housing council makes an annual inspection of the properties within the community reinvestment area for which an exemption has been granted under Section 3735.67 of the Ohio Revised Code. The council shall also hear appeals under section 3735.70 of the Revised Code (persons aggrieved by a decision/action of the housing officer).
