The Special Council Meeting convened on Monday, April 18, 2016 at 7:00 PM in the Council Chambers of the Safety Administration Building. The meeting was called to order by Ms. Whipkey, President of Council, followed by the Pledge of Allegiance and a moment of silent prayer.

### **INTRODUCTION OF PRIOR LEGISLATION:**

#### **ORD #20-2016**

Mr. Pelot offered Ord. #20-2016 for its third reading and asked the Clerk to read it:

AN ORDINANCE APPOINTING AN ASSESSMENT EQUALIZATION BOARD TO HEAR OBJECTIONS RELATING TO THE NASH HEIGHTS GRAVITY SANITARY SEWER SYSTEM IMPROVEMENTS; AND DECLARING AN EMERGENCY.

Mr. Pelot moved to adopt Ord. #20-2016, seconded by Mr. Kernan

Motion passed 7-0. Ms. Whipkey clarified that the hearing date would be on April 27, 2016 and Mrs. Richards concurred. Mr. Rodgers called a point of order asking if we just did a reading? Mr. Rodgers questioning the vote just taken and thought we still need to give it a third reading. Mrs. Richards stated we just gave it a third reading. Mr. Pelot stated that he made the motion to adopt and Mr. Kernan had seconded his motion. Mr. Pelot stated Mrs. Richards called the roll and it passed 7-0. Mr. Rodgers asked if he could withdraw his vote and Mrs. Richards replied, no the vote was taken and it's now been recorded as passing 7-0. Mr. Kernan stated someone could make a motion to reconsider under Roberts Rules of Order, and Mr. Rodgers commented that would not pass with this Council. Mr. Rodgers noted his objection was that the residents in Norton were done a disservice by not allowing the vacuum to go out for bid. Mr. Rodgers stated that he cannot support this legislation with the emergency language.


## **NEW BUSINESS**
